

# Marquita D. Christy Memorial Scholarship Award

# Guidelines

MARQ My Words Foundation, one of Louisiana's newest educational nonprofits, announces the *Marquita D. Christy Memorial Scholarship Award*. Under the Program, one (1) \$500 scholarship will be awarded to a 2L or 3L law student currently enrolled at Southern University Law Center of Baton Rouge, Louisiana, where Marquita D. Christy received posthumous juris doctoral degree in May 2018. Relatives of Southern University employees are not eligible to apply.

### Purpose

The purpose of the *MARQ My Words Foundation* is to advocate higher education, knowledge of legal rights, and health and mental wellness in the African American community through scholarship and community enrichment programs. This scholarship has been established to honor Marquita D. Christy and individuals who have made outstanding positive contributions within their community and to broadly support aspiring law school graduates seeking assistance to fund both educational and personal needs required to complete course of study.

#### Awards

One (1) scholarship award will be available in the amount of \$500 annually each Fall Semester. Awards are for one year only, but recipients may re-apply for a second year. All scholarship awards will be paid directly to the recipients.

#### Eligibility

- 1. Applicants must be currently enrolled as 2L or 3L students attending Southern University Law Center of Baton Rouge, LA.
- 2. Applicants must provide proof of being active in two (2) or more organizations.
- 3. Applicants must be US citizens.
- 4. Applicants must be currently employed: part-time or full-time.

The *Marquita D. Christy Memorial Scholarship* is awarded without regard to race, sex, religion, age, national origin or sexual orientation. The MARQ My Words Foundation will not award scholarships to applicants who are not qualified and reserves the right not to award a scholarship in a given year.

## Selection Criteria

- 1. Demonstrated community service and positive engagement regarding (voter registration/legal rights/activism/leadership roles) in their community, i.e. school/state/country.
- 2. Completed Two Page Essay
- 3. Letter(s) of recommendation
- 4. Academic standing (minimum required cumulative GPA of 3.0).

### **Application Requirements**

To be considered for the *Marquita D. Christy Memorial Scholarship*, applicants must complete an official application and return it to Southern University Law Center. The application must include:

- 1. Completed application forms. Only completed application forms will be considered.
- 2. Completed resume
- 3. One letter of recommendation from a teacher or school official at the college level or industry related professional.
- 4. An official college transcript for the last two years including cumulative GPA.
- 5. A two page (> 1000 words) essay. Maximum word count 1,500\*

All four of the above items must be submitted before the application will be considered.

## Submission of Application Form

Note that the application requires a signature. You may provide an electronic signature, or print out the completed application, sign it and scan it as a pdf.
